However, relatives who are registered residents of Maebashi City and of the same household as the applicant, or those who have submitted a letter of proxy may request certificates on behalf of the applicant. (A letter of proxy is still necessary for a person living in the same building as the applicant but of a separate household.)


※If the applicant is deceased, a successor may be required to display a copy of the family register which can verify death and relationship to the applicant.

※For cases where the applicant is a corporation and the requestor is a representative of that corporation, stamp a registered seal of the representative as indicated in the Applicant section.

※The requestor will be required to display a form of self-identification.

※A fee will be charged to issue certificates. (Does not apply for certain certificates.)

※Certificates of tax payment for Individual Municipal and Prefectural Tax will include forest environment tax starting from Reiwa Year 6.
