(A letter of proxy is still necessary for a person living in the same building as the applicant but of a separate household.)
※If the applicant is deceased, the requestor may be required to display a copy of the family register which can verify death and relationship to the applicant.
※For cases where the applicant is a corporation and the requestor is a representative of that corporation, stamp a registered seal of the representative as indicated in the Applicant section.
※For 6. Inspection / Issuance and 7. Residential Houses, certificates can only be applied for at the City Hall 2nd Floor Tax Certification Counter.
※The requestor will be required to display a form of self-identification.
※A fee will be charged to issue certificates. (Does not apply for certain certificates.)
※Certificates of tax payment for Individual Municipal and Prefectural Tax will include forest environment tax starting from

- 【Important Notes】
- 1 If the certificate requestor is not the applicant or a relative of the same household registered as a Maebashi City resident, a letter of proxy is necessary.

2 Do not separate the application form and the letter of proxy. Bring them attached as one document.

3 If the authorizer is an individual, provide either a signature or both a printed name and a seal.
If the authorizer is a corporation, provide the address, corporation name, and representative name.
Stamp the registered seal of the corporation representative.

4 At the time of certificate application, the proxy must display a form of self-identification (driver's license, etc).
